CAPITOL REPORT

What a time to be involved in Michigan government and public policy. The 2009/2010 legislative session has begun in earnest and many topics are beginning to surface. We at Julian Vail, LLC, are extremely busy meeting, greeting and educating new members of the House of Representatives on the Michigan Private Security Industry. Julian Vail, LLC is working with your President, Dale White and Legislative Committee on issues to be aware of and those to promote in the Legislature. The reception that we have encountered thus far seems to be supportive of the Contract Security Industry.

We report to the membership on a regular basis to keep you informed of the status of bills and the process that we follow in promoting agenda items important to you and the industry.

The information on the rewrite of PA 330 is at the bill drafter. Once the initial language is determined and placed into a draft, we will forward to committee chairman, Don Grant for committee action. The bill has been requested by Representative Darwin Booher. Representative Booher is also working on the unemployment compensation issue that is very important to our membership as employers. This involves investigating why fired employees are still able to draw unemployment compensation when guilty of committing a crime.

President White, Larry Julian and Val Vail-Shirey had a very informative meeting with Michigan Management and Budget about contracts and how they are awarded to vendors. Further information will be forthcoming in future seminars.

Julian Vail, LLC looks forward to continued meetings with the Michigan Contract Security Association Board and move the priorities for this session and targeted legislation for the industry. Please forward your suggestions and ideas for policy changes to Don Grant or President Dale White for review.
